These additions and corrections are intended to bring The Munger Book up to date for those individuals covered herein. So many records are available online that as I researched my husband, Bryce Leon Munger's line from Samuel, second son of Nicholas, I could not ignore the information I found. The results are my contributions to The Munger Book and to Munger researchers.

64. ii. John Munger (Samuel, Joseph, Samuel, Nicholas)

Died: Oct 1797, Poughkeepsie, Dutchess, NY

The first sentence in John's bio sketch reads: "Earliest record of John Munger following his birth appears in a "List of the Foote Company of Militia of the Pals (Paltz), Capt. Zacharis Hoffman, year 1758, Orange Co, NY." This is incorrect copying of a record and cannot apply to this John. In the first place, the correct year is 1738, not 1758. In the second place, there is no John Munger or Monger on Hoffman's list. Instead, there is a John Monger on Capt. Thos. Ellison's list of Militia of the Precinct of The Hig [h]land, but again, the year is 1738, a year or two before this John was born. [Note: The only likely John would be 14. John, grandson of 2. 1760 - John Munger's name, does appear as a private in "A Roll of his Majesty's Fourth Company of Melitia in the Upper Batalion In the County of Westchester where of William Willet Esq. is Collonl James Verplanck Lev't Collonel and Pierre Van Cortland Major." "The Roll is endorsed: "Capt. 1775, Sept - John Munger's name appears on the September, 1775 assessment roll for district no. 9 (southern part Goshen in the Florida part of Warwick including part of the Drowned Lands), John McCamly, assessor. The estimated value of John's property was £8.0.0. ®Ruttenber, Edward. *History of Orange County, New York*. 1881, p. 567. Archive.org.

Can find no record of 1776, residing in Goshen Precinct, Orange Co, NY on land which he bought fr Aaron Forman of the place.

John volunteered to serve in the Revolution, but he is not on any Orange County list of men. Instead, John and brother Benjamin are only on the list of Enlisted men in the Second Regiment of Dutchess County Militia entitled to Land Bounty Rights. ® New York in the Revolution as colony and state. 1781 - August 10 John Monger of the County of Orange bought from Titus Ketchum, yeoman, of the County of Dutchess and Patience, his wife, for £900, Lot 7, a parcel of 100+1/4 acres, 15 perches on the road from Wappings Creek Landing to Fishkill town. This lot adjoined Benjamin Munger on the south. Witness: Abner Brush, Benjamin Munger, J Wells. Recorded 31 Oct 1791 by Benjamin Munger. ®New York Land Records, 1630-1975, Dutchess. 1783, March 20 to 1791, March 5 - On 20 March 1782 John conveyed his Lot 7 to John Wood and Benjamin Monger of Dutchess Co. as Security for a debt of £150 that John owed Jeremiah Drake of West Chester. Because the bond was not written as a mortgage and not recorded at the time and because John Wood died, the conveyance was canceled 5 October 1791. ®New York Land Records, 1630-1975, Dutchess. 1791, October 5 - On the same day that the conveyance of his Lot 7 to John Wood and Benjamin Munger was canceled, John Munger, farmer, of Fishkill and Millicent, his wife, took out a loan of £150 from Elias Van Bunschoten of Sanderstown, Sussex, N.J., using their Lot 7 parcel of 100+1/4 acres, 15 perches on the road leading from Wappingers Creek Landing to Fishkill Town adjoining land of Cap. Cogwise and of Isaac Veal and lands occupied by Jesse Vail and John Hughson as security. ®New York Land Records, 1630-1975, Dutchess. 1795, May 1 - John Monger and Milley, his wife, sold their Lot 7 in Fishkill to Thomas Ray, also of Fishkill, for £600. Benjamin Monger still occupied an adjoining lot. Recorded 17 May 1795. ®New York Land Records, 1630-1975, Dutchess. Deeds, Vol.13 p. 246/8, Image 133/4 of 552, familysearch.org.

1797, 20 October - Under name John Manger, Letters of Administration granted to Millicent Munger widow of John Manger late of Poughkeepsie town and James Munger son to the said John. ®New York, U.S., Wills and Probate Records, 1659-1999.
